Trees Atlanta helps citizens protect and care for trees, shaping the course of development and replanting new trees for the future. Trees Atlanta also educates young people and adults about the diversity and value of our urban forest. In the 2009/2010 planting season, Trees Atlanta planted and cared for 2,791 shade trees in Atlanta with our volunteers and contractors.

"NeighborWoods" program volunteers planted trees in public right-of-way areas and helped home and business owners plant shade trees on private land. Trees Atlanta volunteers planted 1,950 NeighborWoods trees during FY10. Trees Atlanta's Urban Tree program planted 841 fifteen foot tall trees in metro-Atlanta sidewalks, public spaces and on private commercial

Our volunteers build communities as well as plant trees. Trees Atlanta communicates with a volunteer corps of more than 5,000 citizens each week.

Our volunteers are caring citizens from all over Atlanta and include groups of individuals from Atlanta's universities such as Morehouse, Georgia State, Emory and Spelman and the business community including SAP, Delta and The Home Depot. Volunteers contributed more than 14,000 hours of service in FY10 to plant and care for young shade trees throughout metro-Atlanta.
